

# Verification Service Description for Examination Results Issued by the Taiwan Academy of Banking and Finance

December 17, 2025

As many corporations and organizations rely on the professional financial certification exams administered by the Taiwan Academy of Banking and Finance (TABF) as indicators of financial personnel competency, TABF provides a certificate verification service to confirm the authenticity of certificates it has issued.

TABF began issuing digitally-signed certificates in June 2025 for all professional certification examinations and certain statutory training courses. Paper certificates are no longer issued, nor are applications for paper certificate reissuance accepted. Should holders of paper certificates issued prior to this implementation request a replacement or extension, they will receive a digitally-signed certificate.

Two verification methods are available, depending on the certificate format. The verification items are listed in the table below, and described as follows.

1. For holders of digital signature certificates, companies or organizations may verify the certificates independently using the following methods:
  - a) QR scan: each digitally-signed certificate contains a QR code. Organizations may use any QR code scanning application to easily verify the authenticity of the certificate.
  - b) Digital signature: the embedded digital signature ensures the integrity of the certificate and protects it from tampering.
  - c) Cross-checking: visit the verification platform on the TABF website: Customer Service → Certificate Services → Exam Certificates → Electronic Certificate Verification. You may either (1) enter the serial number provided by the certificate holder for database verification, or (2) upload the PDF of the certificate for system-based authenticity checking. The system automatically analyzes the file and displays the results.
2. For holders of paper certificates, organizations must obtain authorization from the certificate holder and follow the verification procedure below.
  - a) Prepare digital copies of the following documents:
    1. **Company Declaration for Certificate Verification (with official stamp)** ([download](#))
    2. POWER OF ATTORNEY for Examination Verification ([download](#))
    3. Copy of the paper certificate
    4. Proof of remittance – the verification fee is NT\$300 per certificate. All associated bank handling charges shall be borne by the applicant.
